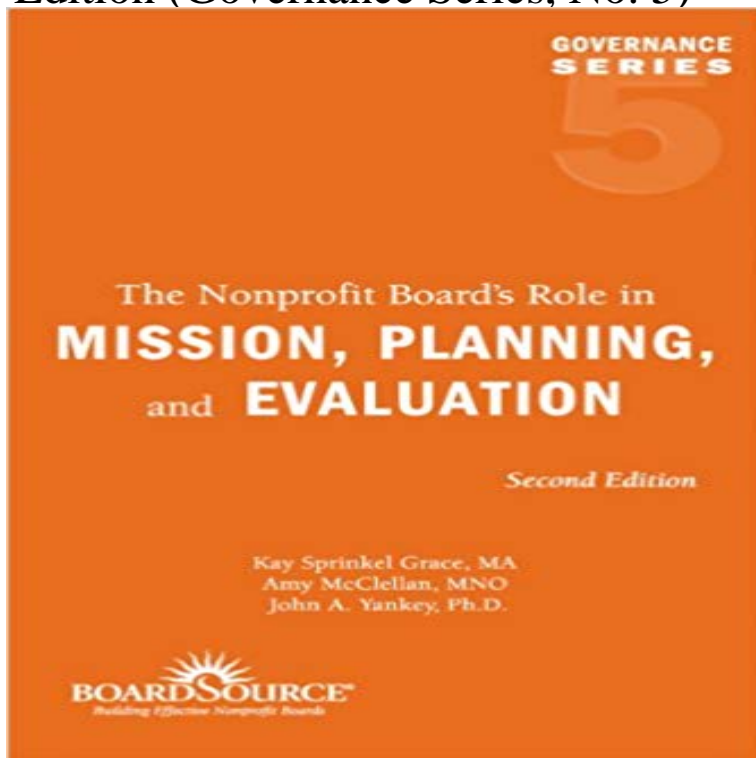


# The Nonprofit Boards Role in Mission, Planning, and Evaluation, 2nd Edition (Governance Series, No. 5)
