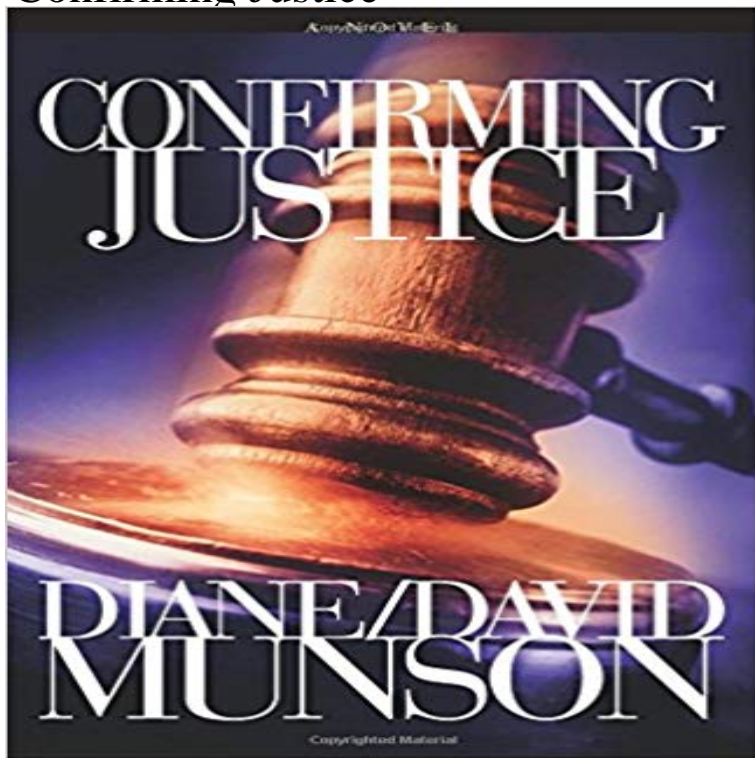


Confirming Justice
