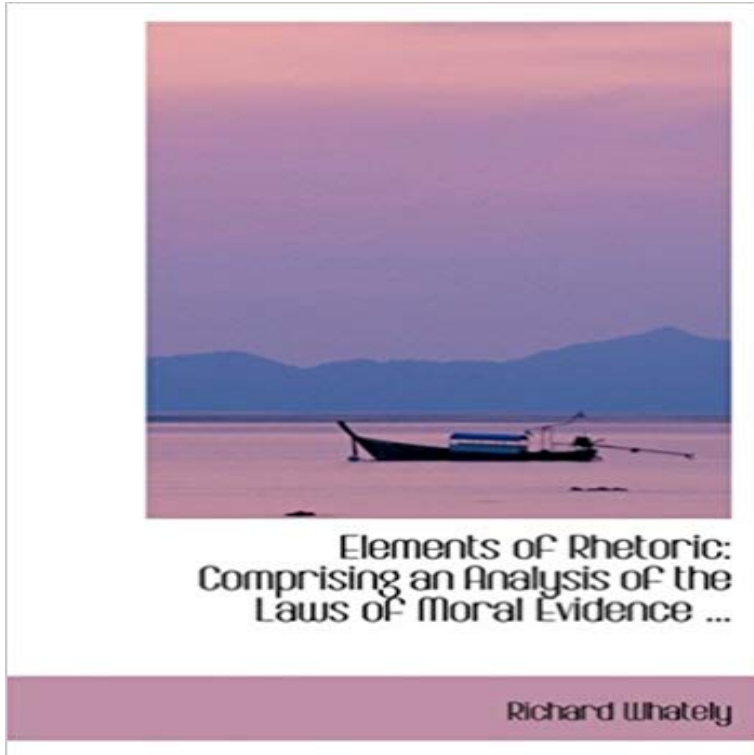


# Elements of Rhetoric: Comprising an Analysis of the Laws of Moral Evidence ...
