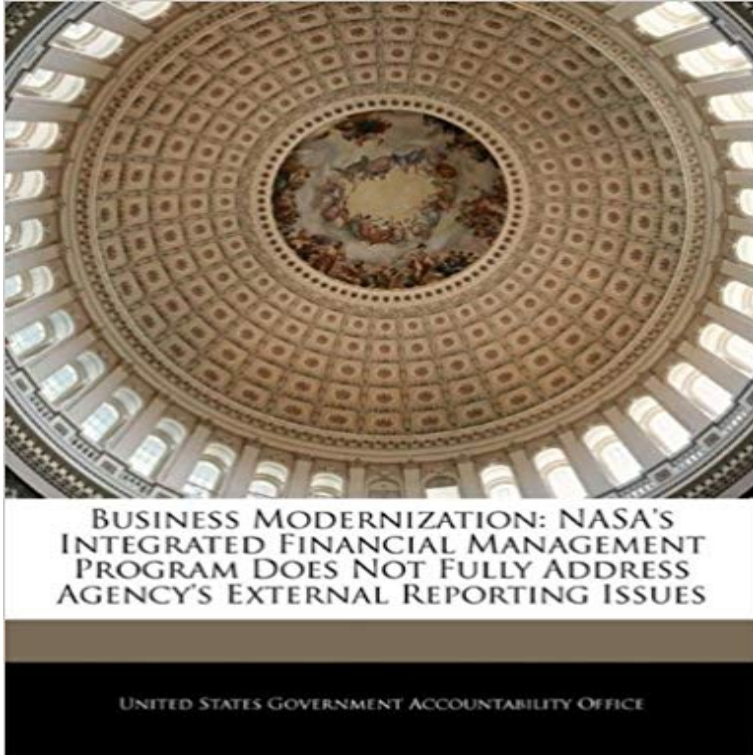


Business Modernization: NASAs Integrated Financial Management Program Does Not Fully Address Agencies External Reporting Issues
