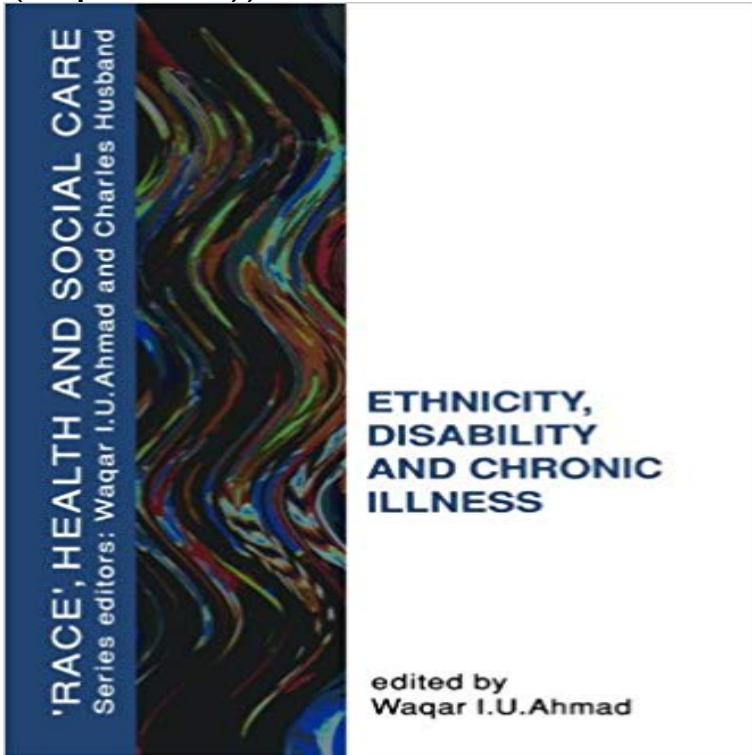


Ethnicity, Disability And Chronic Illness (Race, Health, and Social Care (Paperback))
