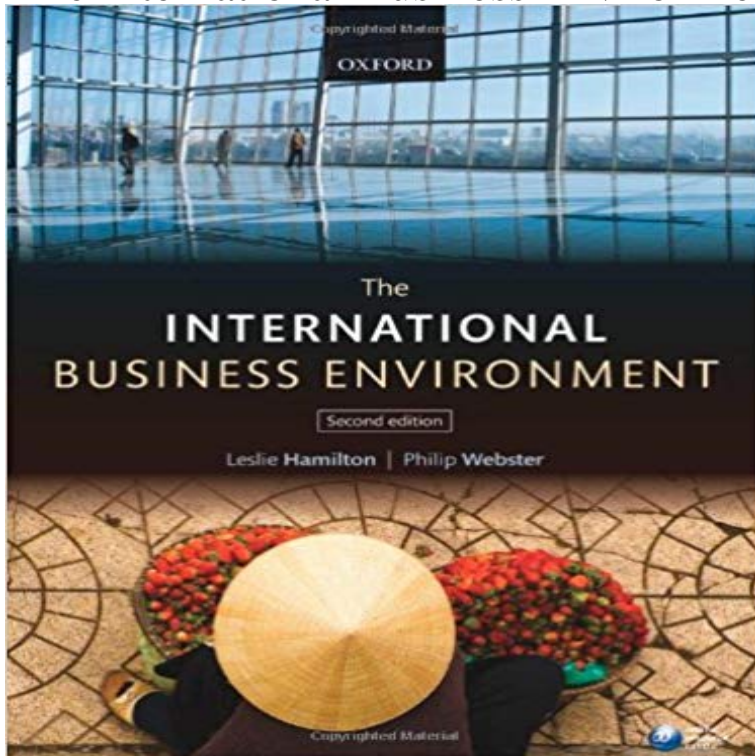


# The International Business Environment
