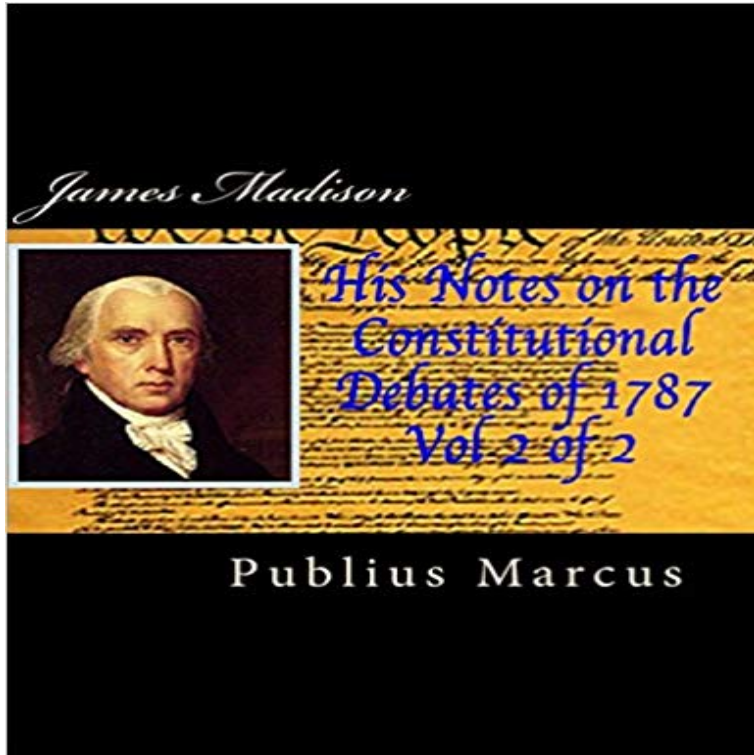


## James Madison His Notes on the Constitutional Debates of 1787 Vol 2 of 2
