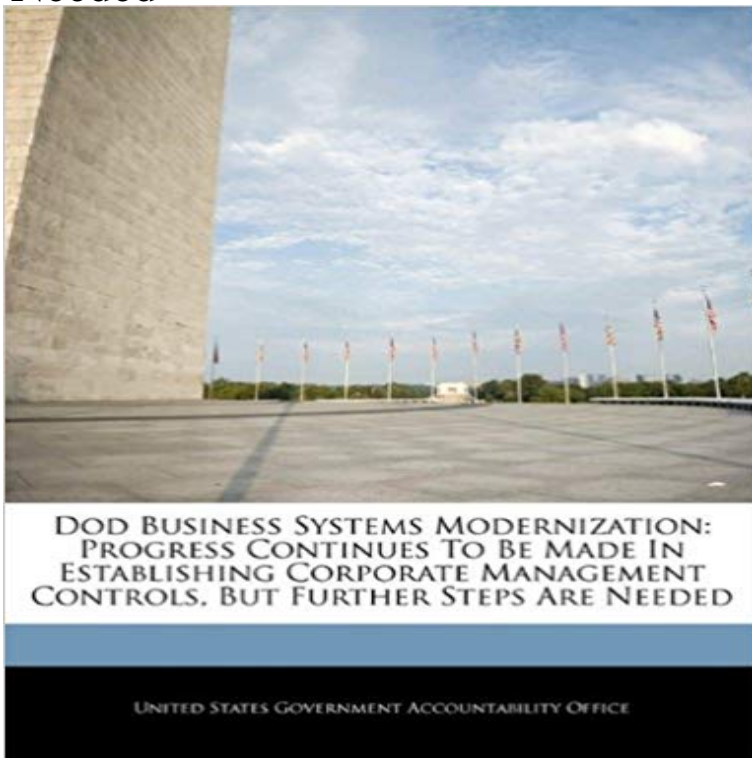


Dod Business Systems Modernization: Progress Continues To Be Made In Establishing Corporate Management Controls, But Further Steps Are Needed
